
### Initial situation

For the internal monthly allocation of income from the company's own funds, Group Controlling utilized an application that did not allow either new fund structures or new allocation keys. In addition, the application did not meet the requirements of the LGT Group anymore, namely the complete traceability of the calculations and assignments.

The income from LGT's own fund structures need to be allocated monthly to the various internal service providers of the LGT Group using a predefined and customizable allocation key, in order that all parties involved are appropriately compensated for their work. The predefined key is be based on different pricing models.


## **Project goals**


- automized monthly allocation of fund income from various fund structures with variable allocation key

#### In conversation

Interview with «Philippe Baumgartner, Group Controller, LGT», about «calculo».

## How did the cooperation with Sowatec come about?

We used various channels to look for a new software solution for the allocation process. The name "Sowatec" was mentioned in discussions with other banks. After doing some research on the website, we made a first appointment.

#### Which criteria were decisive?

We were looking for a partner who understands our needs and processes in the banking sector and has the appropriate experience. From a software point of view, the flexibility of Sowatec's solution was decisive for us, because all structures should be able to be processed using the same application.

## The new solution has been in use for 6 months. How is the feedback from internal stakeholders?

The internal stakeholders appreciate the extended evaluation options and the more specific reports. In addition, we were able to significantly reduce the workload of other departments. Payments can be made directly from calculo thanks to an XML export. In addition, the budget workflow is now an integrated process that no longer has to be done manually.

## What hurdles did the project face during the implementation?

We have been using a new fee split with new allocation logics since the beginning of 2020. Without calculo, we would not have been able to use these software-based logics. Since we had to take this into account in the budgeting, we were pressed for time. Thanks to the open communication and task prioritization, a first version with the most important tools was delivered ahead of time. Budgeting could therefore already be carried out on calculo. Thanks to regular exchange, complicated detailed questions could be discussed in detail so that any difficulties that arose could be responded to at an early stage.

#### How did you experience working with Sowatec?

The cooperation was always professional, reliable, focused and goal-oriented, even under time pressure. Thanks to testing days on site, various points could be processed efficiently.

## Are there any plans for further application areas?

There is currently no further use case in our department. Within the organization, however, the name Sowatec is present and will certainly be introduced as an option for similar projects.
